All reserves should be reviewed and justified regularly (i.e. at least annually). It is good practice to transparently publish both the level and rationale of all reserves.

10.3 Cllr Mayhew mentioned Helen (Parish Cleaner) would be willing to paint the train and make it in a thomas the tank engine theme, all councillors liked the idea and agreed.

10.4 Clerk mentioned he has explored options to get funding for new swing and now hope the new district councillors will help us.

10.5 Clerk to ask for grass to be cut

16.1 Cllr Staff asked if we can get a card and a collection for Cllr Read for his many years service 16.2 Cllr Staff said UK power networks came to cut the tree opposite his house

16.3 Cllr Clements asked if a donation was going to be given to the village hall for cutting down the gorse, Cllr Mayhew said this was not agreed and will not be proceeding with a donation.

16.4 Cllr Clements asked if we make a donation to the parish magazine, which we don't.

17.1 email from resident regarding a hole on the pavement located by no.4 the fitches need repairing and mud on the road/pavement from flooding by the entrance of Judith Avenue – Clerk reported this east Suffolk and highways

17.2 email from a resident regarding the sale of forge cottage and access to the property across the common – council stated as they are not legal owners then it's difficult to comment on the matter.
