Suffolk Coastal to Introduce Garden Waste Collection Charging

Suffolk Coastal District Council will be introducing a charge for collecting garden waste from homes during next financial year (2018/19).

At its Cabinet meeting on Tuesday (5 December 2017), Members heard the council was being faced with mounting financial pressures and reluctantly voted in favour of introducing the charges.

People in Suffolk Coastal will be given the option of paying an annual charge of £43 per garden waste bin (the equivalent of paying about £1.65 per fortnightly collection). They will also be given the option of receiving a replacement free larger (240litre) bin for their garden waste, during the first year of the scheme.

The background to this decision is that, in autumn 2015, Suffolk County Council decided it could no longer maintain its financial support for organic waste recycling at the same level and said it believed the service, provided by district councils, should be chargeable because it is a discretionary service (not one that the councils are required to provide).

At the time, our colleagues in the other districts and boroughs in Suffolk (with the exception of Ipswich Borough Council) decided to implement charges for collecting garden waste.

"In 2015, we decided to maintain the 'free' garden waste collection service and to bear the cost of reduced Recycling Performance Payment support, despite the financial pressures on the council," explained Suffolk Coastal's Leader, Cllr Ray Herring.

"However, at the time, we did recognise that this discretionary service that we provide and we always said we would have to keep this decision under review."

"While Suffolk Coastal wanted to avoid introducing charges for collecting garden waste, we have had to bow to the inevitable faced with the harsh realities of our current financial situation."

"One of the key factors is the dwindling financial support we are receiving from central Government, which is really biting home. So we need to re-examine any options we have open to us to raise money, in order to keep council tax increases down and maintain our services."

"The reduction in the Recycling Performance Payment support from the county council to Suffolk Coastal equated to an annual shortfall of £150,000, rising to over £200,000 in 2018/19, which has been funded through existing budgets."

"Added to this, our East Suffolk Business Plan identifies the need for us to become increasingly financially-self sufficient in the future and Suffolk Coastal also remains committed to an ambitious programme of community-based and major capital investments, such as the current leisure redevelopment, in the coming years."

Suffolk Coastal currently collects about 50,000 tonnes of domestic waste a year. About one third of this (about 15,000 tonnes) is organic waste. This is co-mingled garden (estimated 13,000 tonnes) and food (estimated 2,000 tonnes) waste.

The remaining waste is made up of general 'residual' waste at 22,000 tonnes (44%) and dry recycling at about 13,000 tonnes (26%).

At this time, Suffolk Coastal (through its partner Suffolk Coastal Norse) collects comingled organic waste, which is currently processed into an agricultural soil improver at an in-vessel composting facility at Parham.

This organic waste processing contract ends on 31th March 2019, so a new contract is required to provide waste processing arrangements from April 2019 onwards. At its meeting, Cabinet also agreed to begin work on a new contract, looking at the options of continuing to collect comingled organic waste or moving to only collecting garden waste.

Organic waste containing even a small percentage of food waste requires treating in an animal by-product compliant facility and is therefore significantly more expensive than the less regulated systems for processing garden waste alone (about double the cost – so giving a total difference of about £468,500 a year between the two approaches at Suffolk Coastal, based on current levels of collection).

"As we are just approaching the time when we need to negotiate a new contract for organic waste processing in Suffolk Coastal, now is the obvious time to review how we provide this service," said Cllr Herring.

"Collecting garden waste separately is a discretionary service, which the council is not required to provide. Not everyone has an organic waste bin or uses the service, but we have been subsidising the service from the council tax paid by everyone in the district."

"This is a fairer system, which is closer to what occurs across most of the rest of the Suffolk and Norfolk. Although there is still further work to be carried out, to decide if we continue to collect comingled organic waste or will provide a garden waste only service from 2019."

A timetable for introducing the charge for garden waste collection is currently being drawn up, including details of how and when people can join & pay, should they opt to use the service. As soon as this detailed information is available, we will issue it to local residents.

Homeless Reduction Act 2017 – Preparations for implementation: The recently introduced Homelessness Reduction Act 2017 is regarded as the most substantial change to how homelessness is dealt with since 1977. The Act comes into force in April 2018 and the focus is the prevention of homelessness. Most households at risk of homelessness within 56 days will be covered under the legislation, regardless of whether they are in priority need or intentionally homeless – a major change. This will significantly increase the number of people we will have a statutory duty to look after (with the increase estimated to be 26-51%). To assist Suffolk Coastal District Council in dealing with the increased demand as a result of the Act, the Government has allocated 'new burdens' funding totalling £110,684 to March 2020. This report sets out the new requirements of the Act and its likely impact on the Housing Needs service, along with recommendation to increase the staffing level and develop new service initiatives.

National first for east Suffolk – The big news for us at the start of this month was achieving a national first, when the Rt Hon Sajid Javid, Secretary of State for Communities and Local Government gave his backing to our plans to create a new 'super district' with Waveney. In a written statement to the House of Commons, the Secretary of State confirmed that he is 'minded to' support the proposals to create a new single authority for east Suffolk. "Having carefully considered all the material and representations I have received, I am 'minded to' implement the locally-led proposal I received from Suffolk Coastal and Waveney district councils in February 2017 to merge their two respective councils to become a single, new district council," he said in the statement. The Secretary of State made this historic decision because he considers that: The proposal is likely to improve local government in the area (by improving service delivery, giving greater value for money, yielding cost savings,

providing stronger strategic and local leadership, and/or delivering more sustainable structures); The proposal commands local support, in particular that the merger is proposed by all councils which are to be merged and there is evidence of a good deal of local support; and, The proposed merged area is a credible geography, consisting of two or more existing local government areas that are adjacent, and which, if established, would not pose an obstacle to locally-led proposals for authorities to combine to serve their communities better and would facilitate joint working between local authorities. It is believed this is the first time that the Secretary of State has given his backing to such a plan. He confirmed that the east Suffolk proposal was breaking new ground, saying: "I intend to assess any further locally-led merger proposals that I receive against these criteria." Before he takes his final decision, the Secretary of State has announced there will be a period of time, until 8 January 2018, during which those interested can make further representation to him, including making any suggested modifications to the proposals. He will then make his final decision, which will be subject to Parliamentary approval.

Car parking consultation – As of Friday we carried out the second round of consultation in relation to the implementation of Civil Parking Enforcement (CPE) in April 2019. CPE provides an opportunity for Local Parking Plans to be produced defining off-street and on-street parking control policies. The aim of this consultation is to gain an understanding of local issues and possible solutions and incorporate them into Local Parking Plans, so changes to car parks can be implemented in April 2018. By having their say, local people can help us gain an understanding of local issues and possible solutions to parking in East Suffolk, which can be incorporated into Local Parking Plans, defining off-street and on-street parking policies in the district. Thousands of people flocked to Felixstowe for a fun-filled weekend to celebrate Suffolk Armed Forces Weekend 2017 on 24 & 25 June. As well as providing fun for all the family, the event had a serious side - recognising the huge contribution made by our servicemen and women, as well as marking the important 350th anniversary of the Dutch attack on Landguard Fort (which was the last time foreign forces launched an armed landing on English soil). Help look after beaches this Christmas!

This festive season we're asking people across east Suffolk to help keep our <u>beaches clean</u> by making sure all their leftover cooking fats and oils are put in the bin rather than poured down the sink.

If leftover fat from cooking the Christmas dinner goes down the sink, even with hot water and washing up liquid, it soon sets hard in the cold pipes. When it mixes with other unflushable items, such as wet wipes and sanitary products, it creates what is known as a Fatberg.

The Fatbergs then clog the sewerage pipes and stop the waste water reaching the treatment works as intended. This means the risk of sewage spilling out into homes, streets, rivers and seas is substantially increased.

However, this is easily addressed. Make sure you follow these simple steps this Christmas and give the gift of clean rivers and seas for 2018 and beyond:

- 1. Scrape or pour leftover fat from roasting trays and pans into a heat resistant container then recycle or bin it once cooled
- 2. Wipe out grease left in pans with kitchen roll before washing
- 3. Use a sink strainer to catch any greasy food scraps

With the majority of UK residents cooking a delicious (but greasy!) meal on the 25 December it's important that this message is shared widely in order to protect our environment.
